#### **Communications**

Superintendent's Schedule for February, March, and April 2018
Superintendent Beveridge reviewed his calendar of scheduled meetings for the period February through April 2018. Mr. Beveridge noted that his schedule included several strategic planning sessions with the SOESD Administrative Team as work continues forward on strategic initiatives. Also noted were the following meetings/activities:

# February 1, 2018

Superintendent Beveridge participated in discussions regarding Career and Technical Education during a visit by Governor Kate Brown to the region.

# February 16, 2018

Members Middleton and Webb joined Superintendent Beveridge in a visit to the SOESD's Gilbert Creek Child Development Center. The superintendent's calendar includes other student-related activities including attending an annual fundraiser for PDHH students participating in Gallaudet's Annual Academic Bowl and a field trip with PVI students to the rock-climbing gym.

## March 15, 2018

Southern Oregon ESD is sponsoring a CC4A/STEAM Kick-Off event for students on March 15 at the Grants Pass Airport. Students will learn about after-school plane-building projects, summer camps, and scholarships for pilot training. This kick-off event is the first of many STEAM focused activities planned for students this year and next year.

# Strategic Planning Report

As reported in January, SOESD's Administrative Team has been participating in a series of Strategic Planning meetings. Superintendent Beveridge shared that, based on employee feedback gathered by the Administrative Team, a *Strategic Roadmap* was developed which will serve as the guide to drive needed change forward. The roadmap includes four strategic drivers and twelve initiatives assigned to members of the Administrative Team. Several administrators were present and provided reports to the Board regarding progress toward implementing eight of the twelve strategic initiatives, noting the quality and effectiveness of the planning process, and indicating high staff engagement in providing input into the plan.

#### Education

## Youth Transition Program (YTP)

Andrée Johnson, Special Education Services Coordinator, provided information about the Youth Transition Program (YTP). The purpose of YTP is to prepare students with disabilities for employment or career-related postsecondary education. Preemployment transition activities and supports are provided. The services provided through YTP enhance existing transition services by identifying and breaking barriers to employment for students with disabilities. Seven districts in the region receive these services for their students provided by Jennifer Zon, SOESD YTP Specialist. Funding for the program can be applied for every two years and comes in part through a competitive state grant.

#### Administration

## A. Local Service Plan Update

Superintendent Beveridge briefly summarized his attendance at component school district board meetings to present SOESD's 2018-2019 Local Service Plan (LSP). The deadline for districts to submit their ballots to SOESD is March 1, 2018. Superintendent Beveridge anticipates the LSP will pass and that no district will withdraw from the ESD. He will continue to have conversations with Grants Pass School District administration regarding re-joining SOESD as permitted by statute. Superintendent Beveridge noted that Klamath County School District's Board of Directors voted against the plan. In delivering the district's "no" vote, Superintendent Thede informed Superintendent Beveridge that the vote against the plan was not a reflection of the SOESD, its leadership, the quality of SOESD services, or the value of the SOESD's services in the new LSP model. Rather, the "no" vote from Klamath County School District was due to the increased financial impact that changing to a menu of services had on the district. Member Jensen confirmed he had received the same feedback from Superintendent Thede. The Board will be briefed again in March after all district ballots have been received.

# B. Legislative Update

Superintendent Beveridge provided an update on recent and pending issues impacting education during the legislative session, including the passage of Measure 101 and potential impact on the State School Fund had that measure not passed, the class size bill (HB 4113), increased funding for Measure 98, and charter school students' participation in extra-curricular activities. Mr. Beveridge noted that most of the legislative outcomes have been acceptable to districts thus far.

# C. OAESD P-20 Network Update

Superintendent Beveridge reported on the collaborative work ESDs are doing through their participation in the Oregon Association of ESD's P-20 Network. Mr. Beveridge continues to support the partnership and provided examples of the benefit in ESDs working together to apply for funding which increases opportunities to serve students and improve outcomes throughout the state. The OAESD has proposed a 25% increase in dues for the 2018-2019 fiscal year and also forecasts additional increases after a pending study regarding specific resources that can support the increased partnership activities. Superintendent Beveridge recommends SOESD continue its OAESD membership and believes the benefits from participation outweigh the proposed dues increase.

SOESD's membership in the OAESD currently includes membership in the Association of Educational Service Agencies (AESA). OAESD member districts receive a significant discount in AESA dues by applying for membership collectively. Individually, the AESA dues are nearly double that charged to the OAESD. The OAESD partners are considering the value of AESA membership and will be considering if they should continue paying the annual dues as a collective.

The Board will address approving the OAESD 2018-2019 membership dues at a future meeting.
